#### **ARBOR DAY 2019**

Staff was contacted by Chris Morrison, an Earth Science Teacher at Maize South High School, about the possibility of a joint Arbor Day project with the City of Maize Park and Tree Board on April 26, 2019. Approximately 120 freshman students enrolled in Earth Science classes at Maize South will participate in the project. Each pair of students will plant one tree for a total of 67 trees. In conjunction with Hillside Nursery, City staff identified locations and tree species. Thirty-two trees will be planted around the City Hall campus and thirty-five trees will be planted alongside the new sidewalk on 45<sup>th</sup> street between Plantation and east to the Railroad tracks. This will be the biggest Arbor Day planting for the City of Maize as well as an exciting first partnership with our Maize schools.

**MOTION:** Atchison moved to approve the proposed activities for the City of Maize's

Arbor Day 2019 celebration and recommend the expenditure of

funds not-to-exceed \$10,000 to City Council and staff.

#### LAND AND WATER CONSERVATION FUND GRANT

During the 2019 budget process, the Park and Tree Board requested Capital Improvement Project funding to accomplish one of the Master Park Plan top two priorities: new parkland acquisition or construction of an amphitheater at Maize City Park. The successful completion of either of these

projects would entail the receipt of a 50-50 matching grant from the Land and Water Conservation Fund grant. Staff researched several land opportunities; however, no purchase agreements were reached with landowners in time to complete an application by the April 15, 2019 deadline. Staff is proposing to apply for the grant for an amphitheater at Maize City Park. As part of the Academy Arts District Project, RDG consultants provided the City with a cost estimate for the construction of an amphitheater in the amount of \$500,000. Requesting \$75,000 for 2020 Parks CIP would ensure the City's grant match of \$250,000 for the amphitheater project to be completed in 2020.

Atchison moved to approve the completion of a 50-50 matching grant application from the Land and Water Conservation Fund for constructing an amphitheater at Maize City Park and request a minimum of \$75,000 for 2020 Parks CIP from Council to ensure a full grant match.

# **AGENDA ITEM 7e**

**ITEM:** Vacation of a portion of street right-of-way (V-02-019).

**BACKGROUND:** The applicants are requesting to vacate this portion of street right-of-way in order that their existing barn will be entirely located upon their own property. Currently the north part of the barn is sitting on public street right-of-way.

This situation came to light in March of this year after the applicants inquired with Staff about expanding the existing barn to the west. It was discovered that in the late 1970s a former owner had dedicated an additional 20 feet of street right-of-way along the entire frontage of the property. It is likely that there was no permit pulled for the construction of the barn as this property was in the County until just a few years ago. Therefore, the barn would have been constructed without review by County inspectors.

It is not known what the original purpose of the additional 20-foot right-of-way dedication was for and this is the only property along this stretch of 61<sup>st</sup> Street that has dedicated the additional 20 feet. City Staff has determined that the additional dedication is not necessary or needed for any future developments. The 30 feet of half-street right-of-way (which all the other properties along 61<sup>st</sup> have dedicated) is sufficient for this level and condition of roadway.


On the attached aerial photo the area proposed for vacation is highlighted in orange. This will bring the property line 20 feet north and will match up with both properties to the east and west of the subject property.

At their March 7th meeting, Planning Commission recommended unanimous approval of the vacation. Attached you will find the Staff Report as it was presented to the Planning Commission and supporting documents.

#### Reminder about State Law Debt Limit

The City is still well under the legal limit on its debt. State law limits most cities' debt to 30% of their assessed valuation – but excludes some kinds of debt (such as utility debt for sewer, water, etc.). Of Maize's \$23.725 million in debt, only about \$7.5 million applies toward the state law debt limit.

A RESOLUTION DETERMINING THE ADVISABILITY OF THE MAKING OF CERTAIN INTERNAL IMPROVEMENTS IN THE CITY OF MAIZE, KANSAS; MAKING CERTAIN FINDINGS WITH RESPECT THERETO; AND AUTHORIZING AND PROVIDING FOR THE MAKING OF THE IMPROVEMENTS IN ACCORDANCE WITH SUCH FINDINGS (SANITARY SEWER IMPROVEMENTS/CARRIAGE CROSSING ADDITION PHASE 7).

**WHEREAS**, a petition (the "Petition") was filed with the City Clerk of the City of Maize, Kansas (the "City") proposing certain internal improvements; and said Petition sets forth: (a) the general nature of the proposed improvements; (b) the estimated or probable cost of the proposed improvements; (c) the extent of the proposed improvement district to be assessed for the cost of the proposed improvements; (d) the proposed method of assessment; (e) the proposed apportionment of the cost between the improvement district and the City-at-large; and (f) a request that such improvements be made without notice and hearing as required by K.S.A. 12-6a01 *et seq.*; and

**WHEREAS**, K.S.A. 12-6a19 provides that whenever the construction of any water, stormwater, sanitary sewer or arterial street improvement is initiated by petition pursuant to the Act, the City may require the imposition of a benefit fee on property which is benefitted by such improvements but was not included within the original improvement district established for the levy of special assessments for such improvements; and

**WHEREAS**, the Petition contains a request that the City create an area for which benefit fees will be imposed pursuant to K.S.A. 12-6a19; and

**WHEREAS**, the governing body of the City hereby finds and determines that said Petition was signed by the owners of record of more than one-half of the area liable for assessment for the proposed improvements, and is therefore sufficient in accordance with the provisions of K.S.A. 12-6a01 *et seq.* (the "Act").

#### **RECITALS**

THIS AGREEMENT FOR PROFESSIONAL SERVICES is made by and between the **City of Maize**, **Kansas**, hereinafter referred to as "Owner," and **GARVER**, **LLC**, hereinafter referred to as "GARVER".

The Owner intends to make the following improvements:

Phase 7 Improvements to serve Carriage Crossing Addition, including the following:

- Project 1: Street Improvements to Sweetwater from Lot 70, Block 5 to the north line of the Addition and Longbranch from the west line of Sweetwater to the east line of Lot 11, Block 8 of said Addition. Storm Water Drainage System to be installed per the requirements of the City of Maize.
- Project 2: Sanitary Sewer Extensions to serve Phase 7 Improvements.
- Project 3: Water Line Extensions to serve Phase 7 Improvements.

GARVER will provide professional services related to the improvements stated above as described in this Agreement.

The Owner and GARVER in consideration of the mutual covenants in this contract agree in respect of the performance of professional services by GARVER and the payment for those services by the Owner as set forth below. Execution of the agreement by GARVER and the Owner constitutes the Owner's written authorization to GARVER to proceed on the date last written below with the services described herein. This agreement supersedes all prior written or oral understandings associated with services to be rendered.

#### **TERMS AND CONDITIONS**

## **SECTION 1 - EMPLOYMENT OF GARVER**

The Owner agrees to engage GARVER, and GARVER agrees to perform professional services in connection with the proposed improvements as stated in this Agreement and Appendix A. These services will conform to the requirements and standards of the Owner and conform to the standards of practice ordinarily used by members of GARVER's profession practicing under similar conditions. For having rendered such services, the Owner agrees to pay GARVER compensation as stated in the sections to follow.

## **SECTION 2 - SCOPE OF SERVICES**

Garver will provide engineering design services as described in this Agreement and in Appendix A to this Agreement for each of the Projects 1-3 listed above.

#### **SECTION 3 - PAYMENT**

3.1 For the work described in this Agreement and Appendix A (except for geotechnical services and as may be modified for additional services required), the Owner will pay GARVER on a not-to-exceed lump sum basis for engineering design services, not to exceed \$41,500 and on an hourly rate for construction staking and inspection hourly rate services, not to exceed a total of \$68,800.

## 3.2 Lump Sum Payment

As compensation for the performance of engineering design services required by this Agreement, the Owner shall pay GARVER as detailed in Section 3.3, a lump sum payment of \$41,500 as detailed in Appendix C.

## 3.3 Monthly Invoices (Lump Sum)

GARVER will submit printed monthly statements for performance of lump sum professional services rendered related to lump sum services. Monthly progress billing will be supported by documentation acceptable to the Owner and will include a Project Bar Chart or other suitable progress chart indicating progress on the Project and a record of the time period to complete the work, the time elapsed, and the time period that remains to complete the work. Billings submitted during the progress of the work will be paid on the basis of satisfactory completion of major project tasks as outlined in Appendix A. Payment will be subject to a determination by the City Engineer for the Owner that the major tasks are satisfactorily completed.

## 3.4 Monthly Invoices (Hourly Rate)

- (a) For Construction Staking and Construction Phase Services (Hourly Rate Services), the Owner will pay GARVER for time spent on the Project, at the hourly rates shown in Appendix B for each classification of GARVER's personnel (may include contract staff classified at GARVER's discretion) plus reimbursable expenses including but not limited to printing, courier service, reproduction, and travel. The amount paid to GARVER for Construction Staking Services, Construction Phase Services and expenses is not to exceed \$68,800.
- (b) GARVER will submit printed monthly statements for performance of hourly services rendered and reimbursable expenses incurred. Monthly payments will be based on the amount of hourly work performed in the preceding month. The monthly statements will contain the following information: name and title of person who performed the work; description of work performed; date work was performed; hours of work performed on each

date a person performed work in not less than 1/6 of an hour increments; and the hourly rate of the person who performed the work.

- For the Construction Phase Services, expenses other than salary costs that are directly attributable to performance of GARVER's professional services will be billed as follows:
  - 1. Direct cost for travel, long distance and wireless communications, outside reproduction and presentation material preparation, and mail/courier expenses.
  - 2. Direct cost plus 10 percent for subcontract/subconsultant fees.
  - 3. Charges similar to commercial rates for reports, plan sheets, presentation materials, etc.
  - 4. The amount allowed by the federal government for mileage with an additional \$0.05 for survey trucks/vans.
  - 5. \$15.00 per hour for GPS and Robotic Total Station survey equipment use.

The lump sum, hourly rate and expenses combined will not exceed \$110,300. Should it be determined that Geotechnical Services are required on this project, the Owner will negotiate and directly contract with an approved Geotechnical Consultant as a subconsultant to the City of Maize.

Payments contemplated by Section 3.3 and Section 3.4 not received within 60 days after an invoice has been approved by the Owner's Engineer, will be sub5ject to a one percent monthly simple interest charge.

## 3.6 Additional Services (Extra Work)

For work not described or included in this Agreement and Appendix A but requested by the Owner's governing body in writing, the Owner will pay GARVER, for time spent on the project, at the hourly rates shown in Appendix B for each classification of GARVER's personnel (may include contract staff classified at GARVER's discretion) plus reimbursable expenses including but not limited to printing, courier service, reproduction, and travel.

## **SECTION 4 - OWNER'S RESPONSIBILITIES**

In connection with the project, the Owner's responsibilities shall include, but not be limited to, the following:

- 1. Giving thorough consideration to all documents presented by GARVER and informing GARVER of all decisions within a reasonable time so as not to delay the work of GARVER.
- 2. Making provision for the employees of GARVER to enter public and private lands as required for GARVER to perform necessary staking and inspection services.
- 3. Providing legal, accounting, and insurance counseling services necessary for the project and such auditing services as the Owner may require.
- 4. Furnishing permits, permit fees, and approvals from all governmental authorities having jurisdiction over the project and others as may be necessary for completion of the project.
- 5. Giving prompt written notice to GARVER whenever the Owner observes or otherwise becomes aware of any defect in the project or other events which may substantially alter GARVER's performance under this Agreement.
- 6. Owner will not hire any of GARVER's employees and GARVER will not hire any of Owner's employees during performance of this contract and for a period of one year beyond completion of this contract.

#### **SECTION 5 - MISCELLANEOUS**

#### 5.1 Instruments of Service

GARVER's "instruments of service" provided by this Agreement consist of the printed hard copy reports, drawings, and specifications issued for the Project, and electronic media, including CADD files, are tools for their preparation. As a convenience to the Owner, GARVER will furnish to the Owner both printed hard copies and electronic media of the instruments of service. In the event of a conflict in their content, however, the printed hard copies shall take precedence over the electronic media.

GARVER retains ownership of the instruments of service. The Owner is granted a perpetual license to the instruments of service for the purpose of operation and maintenance of the Project, the modification, extension or expansion of the Project, or on any other Owner project. The Owner will indemnify GARVER and GARVER Consultant from and against claims, liabilities, damages or losses that arise from negligent acts, errors or omissions from Owner's use of the instruments of service for the purpose of modification, extension or expansion of the Project or use on any other Owner project.

## 5.2 Opinions of Cost

Since GARVER has no control over the cost of labor, materials, equipment, or services furnished by others, or over the Contractor(s)' methods of determining prices, or over competitive bidding or market conditions, GARVER's Estimates of Project Costs and Construction Costs provided for herein are to be made on the basis of GARVER's experience and qualifications and represent GARVER's best judgment as an experienced and qualified professional engineer, familiar with the construction industry; but GARVER cannot and does not guarantee that proposals, bids, or actual Total Project or Construction Costs will not vary from estimates prepared by GARVER.

The Owner understands that the construction cost estimates developed by GARVER do not establish a limit for the construction contract amount. If the actual amount of the low construction bid exceeds the construction budget established by the Owner, GARVER will not be required to re-design the project without additional compensation.

Prior to starting work, GARVER shall furnish the Owner with a certificate of insurance that shows GARVER is covered by an insurance policy or policies that include the above types of insurance coverage in amounts equal or greater than the amounts set forth above. The certificate(s) of insurance will contain a provision that provides the Owner will be notified 30 days in advance of an event that terminates or modifies the insurance coverage identified above.

#### 5.5 Records

GARVER will retain all pertinent records for a period of five years beyond completion of the project. Owner may have access to such records during normal business hours.

After completion of each work assignment for the Project, and prior to final payment, GARVER shall deliver to the Owner all original documentation prepared under this Contract (instruments of service), and one (1) set of the record drawing Construction Plans updated to reflect changes. In the event the Owner does not have proper storage facilities for the protection of the original Drawings, the Owner may request GARVER to retain the Drawings with the provision that they will be made available upon written request.

#### 5.6 Indemnity Provision

Subject to the Limits of Insurance set forth in Section 5.4, GARVER agrees to indemnify the Owner for damages, liabilities, or costs (including reasonable attorneys' fees) to the extent the damages and costs are caused by the negligent acts, errors, or omissions of GARVER, its subconsultants, or any other party for whom GARVER is legally liable, in the performance of their professional services under this contract.

Notwithstanding any other provision to the contrary in this Agreement or a Work Authorization and to the fullest extent permitted by law, neither Owner nor GARVER shall be liable, whether based on contract, tort, negligence, strict liability, warranty, indemnity, error and omission, or any other cause whatsoever, for any consequential, special, incidental, indirect, punitive, or exemplary damages, or damages arising from or in

## **SECTION 6 - CONTROL OF SERVICES**

This Contract will be governed in conformance with the laws of the State of Kansas. Any lawsuit filed under this contract will be filed in a court of law located in Sedgwick County, Kansas.

This Agreement may be terminated by either party by seven (7) days written notice in the event of substantial failure to perform in accordance with the terms hereof by the one (1) party through no fault to the other party or for the convenience of the Owner upon delivery of written notice to GARVER. If this Agreement is so terminated, GARVER shall be paid for the time and materials expended to accomplish the services performed to date, as provided in SECTION 3 - PAYMENT; however, GARVER may be required to furnish an accounting of all costs.

## **SECTION 7 - SUCCESSORS AND ASSIGNS**

The Owner and GARVER each bind themselves and their successors, executors, administrators, and assigns of such other party, in respect to all covenants of this Agreement; neither the Owner nor GARVER shall assign, sublet, or transfer their interest in this agreement without the written consent of the other. Nothing herein shall be construed as creating any personal liability on the part of any officer or agent of any public body which may be a party hereto.

## **SECTION 8 - MISCELLANEOUS**

- **8.1** GARVER covenants and represents that it will be responsible for the professional and technical accuracies of work furnished by GARVER under this Agreement.
- 8.2 GARVER will comply with all federal, state and local laws, ordinances and regulations applicable to the Project, including Title VI of the Civil Rights Act of 1964. Further conditions concerning non-discrimination shall be as outlined in Appendix C attached to this contract.
- 8.3 GARVER will designate a Project Manager and/or Project Engineer for the coordination of the work that this contract requires GARVER to perform. GARVER agrees to advise the Owner, in writing, of the person(s) designated as Project Manager and/or Project Engineer not later than five (5) days following the issuance of the notice to proceed on the work required by this contract. GARVER shall also advise the Owner of any changes to the person(s) designated as Project Manager and/or Project Engineer. Written notification shall be provided by GARVER to the Owner for any changes exceeding one week in length of time.
- 8.4 In the event of unavoidable delays in the progress of the work required by this contract, reasonable extensions of the time allotted for the work will be granted by Owner; provided, however, that GARVER shall request extensions in writing, giving the reasons for the requested extensions.
- 8.5 This contract and all contracts entered into under the provisions of this contract shall be binding upon GARVER and Owner and their successors and assigns.

- **8.6** Neither the Owner's review, approval or acceptance of, nor payment for any of the work or services required to be performed by GARVER under this contract or any cause of action arising out of the performance of this contract shall be construed to operate as a waiver of any right under this contract or any cause of action arising out of the performance of this contract.
- 8.7 The rights and remedies of the Owner provided for under this contract are in addition to any other rights and remedies provided by law.

#### APPENDIX A - SCOPE OF SERVICES:

#### **Design Services:**

- Provide a topographic design survey of the subject property including pavement match elevations and the location and depth of utility lines to which this project will connect.
- Determine the location of utility lines as marked on the site by Kansas-One-Call.
- Design improvements to the site consisting of plans for paving and associated earthwork, drainage, water line, and sanitary sewer extensions per the requirements of the Maize City Engineer.
- Prepare complete plan sets for the projects, including construction documents, specifications, and bid forms.
- Schedule a bid date and time coordinated with the City for a public bid opening for the projects.
- Assist the City with the bid letting of the project.

#### **Pre-Construction Activities:**

- Work with the Contractor to establish a work schedule for the project.
- Receive and review shop drawings and material submittals from the Contractor.
- Verify that all on-site underground utility lines have been marked by Kansas One-Call, and arrange for the Contactor to relocate utility lines that may be in conflict with the project.
- Field check all materials on site to assure compliance with the specifications.
- Notify adjacent property owners concerning construction operations.
- Review and coordinate traffic control measures prior to construction.

#### Construction Operations - Staking and Inspection

- Construction staking of the project, consisting of tacked hubs at a specified offset from the pipe at
  fifty-foot intervals and inflection points and appurtenances for the length of the project. Culvert
  pipes will be staked for location and flow elevation.
- Check traffic control measures prior to construction.
- Verify drainage ditches for alignment and grade.
- Check trench width and depth.
- Check that proper trenching methods are being used.
- Ensure that proper care is taken when connecting to existing structures.
- Check that the bedding material meets pipe requirements and trench conditions.
- Check for pipe alignment and grade.
- Check pipe joints and fittings for proper placement.
- Check that pipe backfill meets compaction requirements.
- Ensure that site restoration (driveway removal, yard restoration, street restoration, etc.) is completed properly.
- Revise the original plans to reflect the as-built elevations and appurtenance locations.
- Complete all inspection logs, and compile all inspection information for submittal to the City upon completion of the project.
- · Verify payment requests from the Contractor.
- Coordinate water sampling and testing. Testing cost for water samples will be treated as a pass through cost on the project.
- Observation of pipe testing performed by the Contractor, including pressure testing.

The list of inspection items presented here provides an outline of the duties and the responsibilities of GARVER prior to and during construction of this project, but cannot detail all of the contingencies that may arise during the construction. The engineer in charge of inspection must be able to deal with a variety of circumstances that may arise during the construction process.

GARVER will have a representative onsite during the construction operations as deemed necessary for GARVER to acknowledge that the project was built in substantial conformance with the plans and specifications. GARVER understands that the Owner does not desire full-time construction inspection, but acknowledges that the project engineer will have discretion to determine what times during construction his presence is necessary.

## **CONSTRUCTION AGREEMENT**

THIS AGREEMENT (the "Agreement") made and entered into this day or
, 20_, by and between THE CITY OF MAIZE, KANSAS, a municipal corporation
(hereinafter the "City"), and APAC-Kansas, Inc., Shears Division , whose principal office
is at 3511 S. West Street, Wichita, Kansas 67217 (hereinafter the "Contractor").

- NOW, THEREFORE, for the consideration, covenants and mutual promises hereafter stated, the parties hereto agree as follows:
- **SECTION 1. Contract Documents.** The "Contract Documents" consist of the Agreement and the documents listed in Section 12 of the Agreement (the "Contract Documents"). The documents listed in Section 12 are hereby incorporated by reference herein and are made a part of the Agreement as though they are fully set forth herein.
- **SECTION 2. Work.** The Contractor shall furnish all work as specified or indicated in the Contract Documents. The work to be furnished is generally described as follows:

Labor, equipment and materials necessary to Mill and Overlay (4) four street and roadways for the City of Maize. Locations are as follows: 45<sup>th</sup> Street (Maize rd. to 119<sup>th</sup> street), 37<sup>th</sup> Street North (from N. Manchester to N. Rutgers), W. Central Ave. (Queen Ave. west 1125 LF.) and Cemetery Road West 53<sup>rd</sup> street North.

- SECTION 3. The Work The Work shall be done in accordance with the Contract Documents and under the direct supervision of the Engineer, and the Engineer's decision as to the material used in the Work and the method of the Work shall be final and conclusive. In addition, the Contractor shall execute the Work described in the Contract Documents as necessary to produce the results intended by the Contract Documents or reasonably inferable by the Contract to produce the results intended by the Contract Documents.
- **SECTION 4. Contract Time.** (a) The Work under this Agreement shall be substantially completed to the satisfaction of the Engineer within ninety (90) work days after the Notice to Proceed is issued.
- (b) Liquidated Damages. Liquidated Damages for failure to substantially complete the Work in the time period set in this section will be assessed at the amount and in accordance with the Standard Specifications that are referenced in Section 12 herein.
- **SECTION 5. Contract Sum.** (a) The City shall pay to the Contractor for completion of the Work per unit for quantity in not-to-exceed amounts as set forth in the following chart:

(b) Payment. The Contractor shall be entitled to payments of ninety-five percent (95%) of its progress estimated every thirty (30) days during the prosecution of the Work, subject to the Engineer's approval and certification by the City as to progress and completion of the Work. The five percent (5%) retainage, if undisputed, shall be returned no later than the thirtieth (30<sup>th</sup>)day following substantial completion; however, if any subcontractor is still performing work, the City may withhold that portion of the retainage attributable to such subcontract until not later than thirty (30) days after such work is completed.

**SECTION 6.** Maintenance of Improvements. The Contractor shall maintain the completed Work for a period of two (2) years from the date of final completion as determined by the Engineer without cost or expense to the City. Such maintenance of the Work shall be done in compliance with the plans and specifications.

**SECTION 7. Bond.** Before commencement of the Work, the Contractor shall furnish the following bonds:

- (a) A Performance and Maintenance Bond that guarantees the completion of the Work and guarantees maintenance of the Work following Final Completion for a two (2) year period in the amount of Two hundred thirty six thousand seven hundred forty six dollars and eighty six cents (\$236,746.86), conditioned on the satisfactory completion of the Work and completion of guaranteed maintenance of the Work.
- (b) A Statutory Bond of the State of Kansas in the amount of Two hundred thirty six thousand seven hundred forty six dollars and eighty six cents (\$236,746.86), conditioned upon the payment of all material and labor bills incurred in the making of the Work.
- (c) The Performance and Maintenance Bond and the Statutory Bond shall comply with requirements set forth in the Standard Specifications.

**SECTION 8. Arbitration,** Notwithstanding anything to the contrary in the Contract Documents, the City shall not be subject to arbitration and any clause relating to arbitration contained in the Contract Documents herein between the parties shall be null and void and either party shall have the right to litigate any dispute in a court of law.

SECTION 9. Assignment. The Contractor, acting herein by and through its authorized agent, hereby conveys, sells, assigns, and transfers to the City all right, title and interest in and to all causes of action it may now or hereafter acquire under the anti-trust laws of the United States and the States of action in the particular production of the particular production of the particular production of the particular production of the pursuant to this Agreement.

- SECTION 10. Deferment or Cancellation of Agreement. The Agreement may be deferred or cancelled by the City in accordance with the Standard Specifications.
- SECTION 11. Contractor Representations. (a) The Contractor has familiarized itself with the nature and extent of the Contract Documents, the Work, the site, locality, and all local conditions and laws and regulations that in any manner may affect cost, progress, performance, or furnishing of the Work.
- (b) The Contractor has studied carefully all physical conditions which are identified on the Plans.
- (c) The Contractor has the responsibility to satisfy himself as to any explorations, subsurface tests, reports, or investigations of the subsurface or physical conditions at or contiguous to the site as otherwise may affect the cost, progress, performance or furnishing of the Work as the Contractor considers necessary for the performance or furnishing of the Work at the Contract Price, within the Contract Time and in accordance with the other terms and conditions of the Contract Documents.
- (d) The Contractor has given the Engineer written notice of all conflicts, errors or discrepancies that it has discovered in the Contract Documents and the written resolution thereof by the Engineer is acceptable to the Contractor.
- SECTION 12. Contract Documents. The Contract Documents which comprise the entire Agreement between the City and the Contractor concerning the Work consist of the following:
  - (a) this Agreement;
  - (b) Construction Plans:
  - (c) Proposal Form;
  - (d) Performance Bond;
  - (e) Statutory Bond;
  - (f) The City of Wichita Standard Specifications for Construction of City Projects, 1998 Edition (the "Standard Specifications"), a copy of which is on file with the City Clerk's office of the City; provided that, for purposes of this Agreement, references to "Wichita" in the Standard Specifications shall be replaced with "Maize" and references to addresses in the Standard Specifications that refer to a City of Wichita address shall be replaced with "10100 Grady Avenue, Maize, Kansas 67101."
- SECTION 13. Governing Law. The Contract and Contract Documents shall be governed by the laws of the State of Kansas.

- Since we had so much rain we have graded the gravel streets several times to get them back in shape. Trying to catch up on mowing everything as we can get to it.

They say the columbarium itself weighs around 9000 pounds so we will have quite a foundation for it. We are also going to pour the concrete base for the new directory at the new part as well as a 40'x30' concrete slab to keep dirt and sand so we can get to it all when the ground is too wet to drive on.
- Hydro International is working on the screen again to insure that all is working well with the

The following is a summary intended to keep the Council apprised of the status of ongoing planning projects.

- 1. Comprehensive Plan Update The last round of public survey questions and presentation to the community is being scheduled by Gould Evans. Once these items have taken place the final document will be presented to Council for final approval.
- 3. Zone change at 109, 111 and 117 W. Academy The developer (Joanna Kilgore) is making arrangements for the relocation of an existing building onto the property located at 109 W. Academy. She plans to have this complete before Public Works begins construction on improvements to Academy.
- 4. Zone change at 5500 N Maize Road an application for a zone change for 1.57 acres has been filed to change the zoning of this property from SF-5 Single Family Residential to LC Limited Commercial for the construction of a Dollar General store. The Planning Commission will review this request at a public hearing on June 6, 2019 along with a preliminary plat for the property.
- 5. Zone change at 5711 N Tyler an application for a zone change for 0.34 acres has been filed to change the zoning of this property from SF-5 Single Family Residential to LC Limited Commercial for the construction of a private Supper Club. There is an existing Conditional Use on this property that was granted by the Planning Commission in 2017 which allows banquet facilities and special events on the property. The Planning Commission will review this request at a public hearing on June 6, 2019.
- 6. Eagles Nest 2<sup>nd</sup> Addition final plat The preliminary plat for this property has been reviewed and approved by the Planning Commission. They will now review and make a recommendation to the Council at their June 6, 2019 meeting.
- 7. ## 2. 2019/2020 Budget

The Budget Management Team is developing a budget strategy for presentation and discussion with the Council at the June 3<sup>rd</sup> budget workshop. Although "final figures" will not be available for the workshop, a direction and overall approach for the 2020 will be presented.

## 3. Kansas Special Olympics Summer Games

The 2019 Kansas Special Olympics Summer Games will take place May 31<sup>st</sup> to June 2<sup>nd</sup> at Maize South High School. Kansas Law Enforcement officers will take part in the opening ceremonies on Friday evening. Maize and other area Officers will provide security and handout metals during the games. Come join in!

## 4. Technology

The Police Detective and Municipal Court Clerk attended software demonstrations for software to replace HRePartners. HRePartners is a website created and maintained by

Sedgwick County. It has been provided -- at no cost -- to all municipalities in our southcentral region. Sedgwick County intends on shutting down the service beginning next year. This means a new system will need to be in place by early next year.

This week Sedgwick County issued their Request for Proposals for a new Sedgwick County Treasurer's Tag Renewal Kiosk. The City of Maize has agreed to be the County's test site for the new kiosk. As always, Staff will keep you posted as the process continues.

## 5. Utility Rates

Staff has completed a rate analysis for each month in 2018 using the proposed water and sewer rate structure for 2020. The same analysis has been completed for January – May 2019, in conjunction with the 2019 rate changes as well as the USD 266 rate changes. This provides 18 months of data to establish our final recommendation. A tiered rate structure is currently being tested for the Sewer Expansion Fee as well. Staff will review this data with the committee next week and will present the findings at the June 3<sup>rd</sup> workshop.

## 6. Amphitheater Grant

Kansas Wildlife and Parks will conduct a pre-award inspection of the site at Maize City Park on Friday with staff. Our grant proposal will then be presented to the state panel on June 4<sup>th</sup>. The City will be notified mid-June of grant acceptance or denial.
