2009 INDEPENDENT AUDITORS' REPORT:

Randy Ford, with Busby, Smith & Ford, LLC presented the 2009 Audit Report and the Maize Public Building Commission Financial Summary Information to the Council.

TRANSYSTEMS MAIZE ROAD DRAINAGE DESIGN UPDATE:

Steve Lackey, with TranSystems, addressed the Council concerning options for the design of the new drainage system for the Maize Road Project. Discussion followed. No action was taken.

20-YEAR SPECIAL ASSESSMENT POLICY:

A revised 20-year special assessment policy that places the initial review responsibility on the Planning Administrator rather than a Special Assessment Committee was submitted for Council approval.

MOTION: *Ard* moved to approve the revised 20-Year Special Assessment Policy.
Herndon seconded. Motion declared carried.

HAMPTON LAKES COMMERCIAL PARK DRAINAGE:

A construction contract with Unruh Excavating for the drainage pond improvements in Hampton Lakes Commercial Park Addition was submitted for Council approval.

MOTION: *Clasen* moved to approve the Unruh Excavating Contract for Hampton Lakes Commercial Park drainage in an amount not to exceed \$198,360 and authorize the Mayor to sign.
Stivers seconded. Motion declared carried.
